*MEMORANDUM OF COOPERATION*

This Memorandum of Cooperation (hereafter "MoC"), is made and entered into as of September 3<sup>rd</sup>, 2021, by and

**1. PURPOSE AND SCOPE**

The purpose of the Memorandum of Cooperation is to outline a framework of institutional collaboration not only on a national, but also European basis, between Regional Development Cluster and Grupo Coremsa and determine specific working arrangements between the parties as well as to establish communication channel, with a view to effectively cooperate in manners of common interest, reciprocity, and complementarity.

1. Regional Development Cluster brings activities related to the development of the region's potential in relation to visitors, residents as well as entrepreneurs of the region. These are aimed at supporting the comprehensive development of the region in several points of interest, especially in the field of tourism, polytechnic areas, environment, and environment project, but also supports the social sphere through the coordination of the activities of its members.

2. Grupo Coremsa has made a firm commitment to certified training with an official degree. This desire to offer a competitive and official qualification has led to implement numerous professional training centers and accredited centers, with a wide training catalog of VET programs and certificates of professionalism.



2.1 This MoC is a statement of intent and does not create any enforceable rights or obligations. The Parties will fulfill their tasks under this MoC on a best – effort basis.

2.2 This MoC does not modify or supersede any international laws, nor does it affect any provisions under other multilateral or bilateral agreements in force and applicable to the Parties.

2.3 There will be no third Party beneficiaries to this MoC.

### **3. MUTUAL COOPERATION AGREEMENT**

1. The Parties to the Memorandum have agreed to cooperate with each other in particular, but not exclusively, in the following areas of common interest:

a. providing comprehensive support to small and medium-sized enterprises, in particular in the form of education, counseling, mentoring, support for internationalization, as well as various other direct and indirect forms of assistance.

b. providing comprehensive advisory, information, consulting, and support services.

c. development of small and medium - sized enterprises with innovative potential based on technology transfer, use of knowledge and outputs from R&D and academic environment, as well as companies in the field of industrial design, creative and others sector of the economy.

2. The Parties to the Memorandum agree that in the areas of common interest mentioned in the above-mentioned paragraph of this Article of the MoC:

a. will provide each other with all necessary cooperation and information concerning their cooperation,

b. will exchange experiences and examples of good practice,

c. will mutually promote and support the developed activities, projects and services provided,

d. will cooperate in organizing events and / or international projects.

### **4. VALIDITY OF MoC AND ITS TERMINATION**

1. This MoC is concluded for an indefinite period.

2. This MoC shall come into force and effect on the date of its signature by both Parties.

3. This MoC may be amended at any time:

a) by written consent of both Parties or

b) by amendment of any of the Party, even without giving a reason.

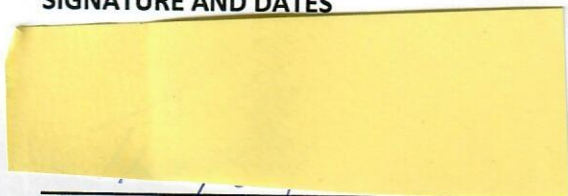
4. The notice period is one month and starts from the first day of the month following the month in which the notice has been delivered to the other Party.
